NOTE:- IF ANY OF THE ABOVE OBJECTS IS FOUND TO BE INCONSISTENT WITH THE OJECTS OF A PUBLIC CHARITABLE INSITUTION UNDER SECTION 11 OR ANY OTHER SECTION OF THE INCOME TAX ACT,1961 OR ANY OTHER LAW APPLICABLE TO SUCH TRUSTS AS NOW ENACTED OR AS MAY BE ENACTED OR AMENDED AT A FUTURE DATE, THE OBJECTS STATED ABOVE WILL BE TRATED AS SO MODIFIED TO ACCORD WITH SUCH ALW OR AMENDDED LAW SO THAT ANY CONCESSIONS, PRIVILEGES, CONDITIONS OR REGULATIONS AVAILABLE TOA ND APPLICABLE TO SUCH PUBLIC CHARITABLE INSTITUTIONS WILL BE AVAILABLE OR APPLICABLE TO THE TRUST AS WELL SO THAT THIS TRUST WILL CONSTINUE TO RETAIN ITS CHARACTER AS A PUBLIC CHARIATATBLE INSTITUTION WITHOUT PROFIT MOTIVE WITH PUBLIC CHARCTER WITHIN THE MEANING OF ALL SUCH LAWS. ## ADDITIONS AND AMENDMENTS IN THE RULES AND REGULATIONS:

The Trustees may meet as often as it may be considered proper and necessary for the discharge of the Society of the Trust. Further, a meeting of the Trust which is called as Annual Meeting shall be held once a year and not more than 18 months from the last meeting.

### **ADDITIONAL CLAUSE AS 6:**

- (1) That the funds of the institution would be invested as per Section 11(5) of the Income Tax Act, 1961
- (II) The institution is irrevocable.
- (III) The books of accounts would be maintained regularly and would be audited by a Chartered Accountant.
- (iv) The funds of the Trust would be utilized only towards the objects and no portion of it would be distributed in any manner to the Trustees or persons defined in Section 13(1)(c) of the Income Tax Act, 1961.
  - (v)In case of winding up / dissolution of trust/society, the net funds/assets would be transferred to a trust/society having similar

objects and enjoying similar objects and enjoying exemption under Sec. 12A and approval under Sec. 80G of the Income Tax Act, 1961.

The benefit of the objects of the Trust/Society would be available to general public irrespective of Caste, Creed, Religion or Sex.

(vii) Any amendment to the Trust Deed/MoA/ Bye-Laws/Rules & Regulations of the Trust/Society would be carried out only with the approval of the Commissioner of Income Tax, having the jurisdiction on the Trust.

(VIII) The Charitable activities would be confined to the territory of India only
